# **AMI Program Update**

NEW AUTOMATED METER SYSTEM REPLACES OUTDATED TECHNOLOGY

As we discussed at the 2019 Parke County REMC Annual meeting, the Advanced Meter Infrastructure (AMI) upgrade project will continue through 2020.

As of July 2019, we have over 40% of the new AMI meters installed. One question that we frequently get from our members is "why do you need to replace all those meters?"

The easy answer is: The existing system is obsolete and we received notice that parts and support will no longer be available in the near future. In order to keep our service reliable, we must upgrade the older AMR meters.

The new AMI was selected in 2018 and we began testing the new system later that year.

We are pleased with the capabilities of the new system and the progress of installation.

A Parke County REMC employee will be coming to your residence, business, or farm to change our meter. They will be able to answer your questions concerning the new system. Please visit the Parke County

# **Understanding "Demand"** and **Upcoming Rate Increase**

One of the biggest financial challenges of a co-op is structuring our electric rates so that our members pay the least amount possible, while still covering all the business costs of the cooperative.

One way we make sure our rates are both fair to our members, and cover our expenses, is by periodically commissioning an independent company to perform a rate study.

After the rate study in 2017, we reviewed our costs and feel it is necessary to have an increase on our demand, effective January 1, 2020. Please note, this is not an "across the

board" rate increase, but new rate for a very specific type of electric use.

The new rate will go into effect on the January billing for demand, that will be calculated based on December 2019 electric use.

A brief explanation of a "demand charge" is the total amount of electricity being used by an Industrial and Commercial member at any one time. Demand varies from hour to hour, day to day and season to season. This electric use, when expressed in Kilowatts, is called the 'demand" on the system. The member is charged for the highest demand recorded over a 15-minute period during the billing cycle. You can see a detailed listing of the new demand rates below.
